VII. Communications Report

- Deputy Director Whitfield stated that we eliminate Cintas, who was supplying us with paper towels and toilet paper. We are now purchasing our own supply. This will save both ops and detention money. Thanks to Nick Flood who installed all the new equipment upstairs and downstairs
- We did have some issues with the Barrington PD radio it was found to be a bad T1 card from AT&T. This was replaced
- Antioch intercom isn't really working. They are waiting on a piece to be replaced that was ordered.
- > We have a site visit from IAED. This is the EMD program we use
- \blacktriangleright The Audit will be starting the week of the 28th
- We sent out for quotes for property insurance through OneDigital. Due to the detention we will be staying with VFIS
- Quotes were received regarding going internet based for faxing instead of having a line from AT&T. This would be about a \$1200 year savings.
- > Detention Door system was replaced, and most officers were input into the system.
- Next month we are being recognized and awarded for obtaining are ACE Accreditation. I will be accepting the award on behalf of CenCom.

- Radios are currently being programmed by Miner with the alias. Working with Jeff Lilly we have the correct code plug. We changed one of the detail channels to have a combined FD/PD channel for events.
- Training was set up for the first week of August. This will include 2 4hour training sessions for police and 1 4hour class for Fire. We are allowed up to 15 people per class

IX. New Business

a. Frontline PSS

Deputy Director Whitfield spoke about the different modules that some of our member agencies use that have been very beneficial. Currently each department pays their own subscription. With the combining of the systems CenCom would start paying the bill.

Some departments already paid. What would be the total bill be for us with the current members already paid. Next year CenCom would get the entire bill next year.

The Module that CenCom would be using would be the QA Tracker. This will enable CenCom to have a more uniform tracking system for employees with the quality assurance that we currently do. The API feature is something that we will have to check with LCETSB to see if that is allowed. Currently Lake County Sheriff and FoxComm use the frontline system without the API.

Deputy Director Whitfield was directed to get some basic questions answered and update the Chiefs at the next meeting. The Chiefs agreed to start the process with Frontline.
